



(1) Memberships:

(k) Lifetime Member:

(2) General Meeting and its functions:

General meeting will be called for with the written application of 3/5th members. They should state the reason for calling the meeting in the application.

majority and such decision will be considered as decided by the general
meeting.

(6) Privilege of the Secretary :


